




Product Introduction / 产品介绍




Setting / Collapsing a Tripod 打开/合拢支架

Pull the mobile phone holder upward to extend the selfie stick. Then, tap the bottom of a tripod against the ground from a height of $\sim\!10\text{cm}/3.9\text{in}$ to trigger the automatic extension of the tripod.

首先将手机支架拉手向上拉出,然后垂直地平面大约 10cm高度落下,即可自动弹开自拍杆三脚架。



To fold, graps the middle section of the selfie stick with one hand and the tripod base with the other hand. Push the selfie stick into the tripod base. 合拢时一只手握住自拍杆中部位置,另一只手将拉杆逐节推回手柄套筒内。



Fixing Mobile Phone Holder / 手机固定支架

Position the phone horizontally, tilt it 45° away from you, insert it into the phone holder, and gently push up wards to secure it.



Charging of Remote Control / 遥控器充电

Charge the tripod remote control using a USB cable. A low battery triggers a red flasing indicator. During charging, the indicator is solid red, turning off upon completion.
